Objective b. Project coordination and communications support: A significant effort was put toward soliciting and organizing site plans and budgets for 2019. A spreadsheet tracking project contacts has been kept up-to-date, with tabs added to budget information.

Objective c. Compile Best Management Practices: No effort to date has been put toward the objective of compiling and disseminating a best management practices review (c.i).

#### Difficulties Encountered in Meeting Goals and Objectives:

No unanticipated challenges have been encountered, although transition in TRTLS created additional administration and coordination challenges.

#### Activities Anticipated Next Quarter:

- Most of the budgeted time in sections a and b of the scope of work has been expended.
- In section c, we will use the remaining budget to incorporate best management practices in the Xerics of the Northeast Report and produce a working draft by the time the contract closes at the end of February. (This was intended to be a living draft, where new information derived from site experimentation can be added throughout the project.)
